

Data was also obtained from the United States Geological Survey. Ortho Imagery was originally produced by the Tennessee Department of Transportation in 2013 and has a 10 inch ground sample distance.

The floodplains and floodways that were transferred from the previous FIRM may have been adjusted to conform to these new stream channel configurations.
